Psychologists Registration Act

PAM Council has received a response from the Minister of Health regarding our inquiries about the status of the proposed new act. We were advised that the committee looking at this continues to work and that a report from them is expected early this year. We were also

assured that when legislation is drafted, further consultations would occur. PAMs proposed by-lay changes have also been forwarded to the Ministry of Justice for drafting, although this has not yet started.

The Privacy Compliance Tool

Ombudsman Manitoba has prepared a self-assessment instrument available online for anyone who is seeking information about how to comply with The Freedom of Information and Protection of Privacy Act (FIPPA) and The Personal Health Information Act (PHIA) of Manitoba. This Privacy

Compliance Tool (PCT) helps people review their degree of compliance with privacy legislation and identifies recommended best practices. The website is www.ombudsman.mb.ca, Access and Privacy Division.

Professional Wills

Psychologists have a professional responsibility to ensure ongoing care for their patients and to protect the confidentiality of records that extends past active practice, as occurs with retirement or even the practitioner's death. In the event of the psychologist's death, management of clients and records can be facilitated proactively by ensuring that colleagues are aware of where files are stored, how they are organized, and how active/closed cases are identified. When working in an institutional setting, there is typically a structure in place to take over the service and records. However, in private practice, where the psychologist may be working independently and in relative isolation, it is important to give some thought as well as direction regarding the management of the practice in the event of unexpected death. This direction can be provided through a clause in a personal will or through a professional will, depending on the circumstances of the psychologist's practice (e.g., other employees, partnership, corporation).

An example of one such clause is: "I direct that my Trustees take all steps necessary and reasonable in the circumstances to appoint a psychologist registered to practice in the province of Manitoba to secure all my patient files and records and assume conduct of the care of any active patient cases of mine on my death. It is my wish that Dr. XX of the City of Winnipeg, in the province of Manitoba, be so appointed if he/she is willing to do so." Obviously, the content of such a clause could vary from practice to practice and should be developed in consultation with a lawyer.

The psychologist might also prepare a brief letter, periodically updated, that gives an overview of the practice management, including file storage, accounting books and billing, and relevant passwords for the computer, for example.

A recent APA Monitor (FEB, 2003) offers some similar suggestions about setting up a "professional will" and identifying a health professional to serve as an executor who would close the psychologist's practice. Some highlights from this article include:

- The executor should know where client records are kept and how they are organized
- Billing and financial records should be located
- Patient contact information and appointments should be located
- Relevant passwords and access codes should be listed
- The psychologist should state how they wish patients to be notified
- The malpractice carrier should be informed
- Compensation for the executor should be specified

The point was made that if the psychologist does not have such a professional will then it may fall to the spouse or to close colleagues to cope with these issues and that this can be a significant emotional burden.
